MOTION CARRIED.</p> <p>SHANE MOVED THAT IN ORDER TO JUDGE THE STATE FINALS JUNIOR DIVISION A JUDGE MUST HAVE JUDGED A JUNIOR HIGH DIVISION RODEO, JUDGED A HIGH SCHOOL DIVISION RODEO AND BE APPROVED BY THE EXECUTIVE BOARD. MOTION CARRIED.</p> <p>SHANE MOVED THAT IN ORDER TO JUDGE THE HIGH SCHOOL DIVISION STATE FINALS A JUDGE MUST HAVE PREVIOUSLY JUDGED 5 RODEO PERFORMANCES IN THE CALENDAR YEAR, BE A RECOMMENDED BY THE YOUTH ADVISORY COMMITTEE, APPROVED BY THE JUDGES COMMITTEE AND THE EXECUTIVE BOARD.
