Contract must be completed and received in the UHSRA rodeo office no later than 5:00 PM June 1, 2011 to be eligible for consideration.(1680 E 7650 S South Weber, UT 84405). Please include booth space fees.

<u>Booth Space Fees:</u>	Wrangler Division	\$200 – 10x10 booth space only
	High School Division	\$350 – 10x10 booth space, 1 PA announcement per performance, flyer in contestant packet.
	Both Divisions	\$750 – 10x10 booth space, ½ page ad in State Finals program, signage in 1 arena at State Finals, PA announcement at all performances at State Finals, 4 individual VIP passes.
	Priority Booth Placement	\$100 – For an extra fee of \$100 Exhibitor may receive a priority booth space upon UHSRA Approval on a first come first serve basis.

Sponsor will provide:

Flyers for contestant packets, banners for arena, script for announcer, ½ page camera ready ad or PDF for the program.

Miscellaneous Provisions:

1. UHSRA retains the right to deny Exhibitor participation in the trade show, before or during the trade show, if Exhibitor violates the terms of this contract or for other good cause. If Exhibitor is denied participation, any refund of the booth space fee is at the discretion of the UHSRA. In no case will refunds be granted if participation is denied within two weeks of the trade show event.
2. A copy of the signed contract will be returned to Exhibitor. Without specific authorization from the UHSRA, Exhibitor is not entitled to participate in the trade show. If Exhibitor does not receive a returned, signed contract, Exhibitor must assume that Exhibitor has not been authorized to participate in the trade show.
3. Monies received by UHSRA from Exhibitors not granted authorization to participate in the trade show will be returned to the Exhibitor.
4. Upon approval from UHSRA, Exhibitor is entitled to display and exhibit only those products or services specifically listed above at the trade show for the duration of the trade show event.
5. Exhibitor agrees to treat trade show patrons, the UHSRA, those participating in and attending rodeo events, and other participants in the trade show with courtesy and respect.
6. Exhibitor agrees to comply with all applicable laws and regulations governing sales and conduct toward consumers. Exhibitor also agrees to abide by any guidelines established by owners of property where the trade show is held.
7. Exhibitor is not an agent or representative of UHSRA by virtue of Exhibitor's participation in the trade show.
8. Exhibitor agrees to provide written notice, as soon as practical under the circumstances, to UHSRA if, after receiving authorization to participate, Exhibitor will not attend the trade show. The parties acknowledge that having unoccupied booths at the trade show, or having to find booth occupants on short notice, may represent a damage to UHSRA above and beyond the amount of the booth space fee. In the event of cancelation by Exhibitor, any booth space fee refund is at the discretion of UHSRA, but in no case will a refund be issued for notice of cancelation received within two weeks of the trade show event.
9. This contract represents the entire agreement between the parties, and expressly replaces, supersedes, and cancels any prior oral or written agreement or communications on this subject matter. Any modification or amendment to this contract must be made in writing and must be signed by the parties.

10. The parties acknowledge and agree that this contract shall be interpreted, construed, and enforced according to the laws of the State of Utah. Any dispute with respect to the obligations of the parties to this contract shall be laid before a court of competent jurisdiction in the State of Utah.
11. Exhibitor shall indemnify and hold UHSRA harmless from and against any and all demands, claims, liabilities, obligations, losses, expenses (including attorneys fees and costs and court costs), or damages of any kind or nature arising out of Exhibitor's participation in the trade show.
12. Failure by either party to insist upon the strict performance by the other party of any obligation under this contract shall not constitute a waiver of that party's right to insist on full performance in the future, or a waiver of any remedy for a breach of the contract.
13. There will be only 1 Exhibitor allowed per booth space.
14. No fees will be discounted for Exhibitors opting to participate for less time than the entire show.
15. No Exhibitor shall be allowed to set up a booth until all fees have been paid in full.
16. Any Exhibitor wishing priority placement at the show will pay an additional \$100.00 per booth space according to space availability upon UHSRA approval on a first come first serve basis.
