DISCUSSION	Queen Contest Discussion — The Queen Committee proposes that queen contests not be held on Thursday due to the amount of time the girls are needing to take off school. Some of the same complaints have been expressed by members participating in cutting and reined cow horse events. Discussion.
	JUSTIN MARTIN MOVES THAT ANY CLUB WISHING TO HOLD AN EVENT ON THURSDAY EVENING MUST GET APPROVAL FROM THE MAJORITY OF THE EXECUTIVE BOARD TO DO SO. SECONDED BY DOUG MADSEN. MOTION CARRIED. ONE OPPOSED.
	The Queen Committee would also like to see the points system changed for the State contest. Committee will submit a new points system to the board for approval.
	SAM TAYLOR MOVES TO APPROVE THE NUMBER OF QUEEN CONTESTS FOR THE 2018-19 SEASON TO BE 4 IN THE FALL AND 4 IN THE SPRING AS SUGGESTED BY THE QUEEN COMMITTEE. WILL GLEAVE SECONDS. MOTION CARRIED. UNAMIOUS.
	Rodeo Gate Fees The South Summit Rodeo Team submitted an idea for charging contestants a gate fee with their entries, then proposing that clubs no longer take gate fees at the rodeos. Wendy requested information from all clubs on their gate and program income and ran several scenarios with the number of contestants at each rodeo and the amount of income received by clubs. From discussions with secretaries who submitted information, they were in favor of the proposal. Key points include that most contestants' parents would pay \$12 a weekend to get into the rodeo. The clubs need several volunteers to man the entry gates into the rodeos. The lines for entrance can get long and cause traffic problems. Clubs could still sell day sheets at the doors. After running the numbers, a \$4.00 gate fee was an average amount decided upon for a gate charge. After discussion with the Executive Board, the following motion was made:

DOUG MADSEN MOVES TO INSTITUTE A \$4.00 GATE FEE CHARGE PER CONTESTANT PER RODEO TO BE PAID WITH THEIR ENTRIES TO THE HOSTING CLUB AND REMOVE ALL OTHER GATE ENTRY CHARGES TO RODEOS. SECONDED BY SHAMUS. MOTIONS CARRIED UNAMIOUS.

Three Arena / Perf Rodeo Proposal

Discussion on issues with the length of rodeos, concerns from judges, and parking issues.

JUSTIN MARTIN MOVES THAT EACH HIGH SCHOOL RODEO WILL EITHER USE THREE ARENAS OR HOLD A PERFORMANCE RODEO. SECONDED BY DOUG MADSEN. MOTION CARRIED. ONE OPPOSED.

Club Contracts / Ground Rule Cattle Approval

After much discussion over several years on how to solve rule infractions with cattle, contractors, and club contracts the following has been proposed:

SHAMUS MOVES THAT THE STOCK AT EACH RODEO WILL BE INSPECTED BY A RODEO DIRECTOR, A JUDGE, AND A REPRESENTATIVE FROM THE HOSTING CLUB. THE RODEO DIRECTOR, JUDGE, AND CLUB REPRESENTATIVE WILL THEN HAVE THE FINAL SAY FOR APPROVING CATTLE TO BE DEEMED ACCEPTABLE FOR THE RODEO. ANY NEW GROUND RULES SHALL BE POSTED AT THE RODEO OFFICE. IF CATTLE ARE DEEMED NOT ACCEPTABLE FOR PERFORMANCE THEN THE PREVIOUSLY INSTITUTED FINES TO CLUBS, FOUND IN THE UHSRA RULES, COULD BE ASSESSED. THE CLUB WILL THEN HAVE THE RESPONSIBILTY TO COLLECT THE FINE FROM THEIR CONTRATOR IF THEY CHOOSE TO DO SO. SECONDED BY JUSTIN MARTIN. MOTION CARRIED UNAMIOUS.

Directors over clubs are asked to make sure they get in touch with the clubs prior to the rodeos and discuss contractors and expectations.

Jr High State Finals

Mark proposed to add an extra day to the Jr High State Finals due to the increase of members and participation at State Finals.

SAM TAYLOR MOVES TO BEGIN ARENA SETUP, THE SHOOTING COMPETITION, AND THE CONTESTANT MEETING FOR JR HIGH STATE FINALS ON THURSDAY AFTERNOON, THEN DO THE 1st PERF THURS PM/FRI AM, 2ND PERF FRI PM/SAT AM, THEN HOLD THE SHORT GO ON SAT PM. DEPENDING ON APPROVAL FROM WASATCH COUNTY. SECONDED BY WILL GLEAVE. MOTION CARRIED.

SECONDED BY KELLY ANDERSON. MOTION CARRIED. UNAMIOUS.
