	Discussion on High School Cutting and Reining Cow Options MOTION BY RUSTY WEBSTER 2 <sup>nd</sup> BY JOSH BAXTER FOR Option #1 for Cutting <i>OPTION 1: Cutting Horse Event will be offered for each approved qualifying,</i> <i>practice and/or state/province or district rodeo. Cutting may be held in conjunction</i> <i>with the rodeo or held at a different time and location for each rodeo. Cutting must be</i> <i>offered the same number of times as all the other events, such as pole bending, bull</i>

riding, etc. All points earned throughout the year and at the state/provincial finals will be applied toward the All Around. Option #2 for Reined Cow Horse OPTION 2: Reined Cow Horse Event must be offered a minimum three (3) times within each district and/or state/province and their finals. Only the points earned at the finals will count toward the All Around. Points earned at the qualifying events and the state/provincial finals will be used for the year end Reined Cow Horse Champion. They must be offered the same number of times as all the other events, such as pole bending, bull riding, etc. If OPTION 1 is used, all points earned throughout the year and at the state/provincial finals will be applied toward the All Around. PASSED UNANIMOUSLY Discussion on a proposal from Wasatch Front Rodeo club to hold a JH rodeo on October 30-31,2020 due to the fact their spring rodeo was cancelled.

JOSH ALLAN MOTIONS TO NOT ALLOW THE ADDITIONAL RODEO 2<sup>ND</sup> RUSTY WEBSTER

Discussion on 3 arena rule. The board referred to the original rule which states clubs have the option to not have 3 arenas. Rodeo formats: Clubs can choose from the following rodeo formats based on available dates: 1 all day performance; requires (3) three

arenas, 2 performance on separate days; requires (2) two arenas, 3 performances in two days; requires (2) two arenas, and 3 performances on (3) three separate days; requires (1) one arena The board has turned this over to the planning and steering committee to revisit at mid-winter meeting.
