Spikers has agreed to host a two-day rodeo to fill the April 2nd date. Bear River will be required to pay the \$3500 fee for not hosting in the 2021-22 season.</p> <p>Discussion on Proposed 2022-2023 Rodeo Schedule Recommendation of the Planning and Steering Committee to accept the Current Proposed Schedule for 2022-2023 - Will submit Proposed schedule to Executive board for a vote Bear River, Rich, and Morgan Rodeo propose that they be allowed to co-host one qualifying rodeo in the 2022-2023 season. Each club is struggling with membership numbers and hopes that combining to have a rodeo will allow them to keep their clubs intact and meet the state's requirements to host a rodeo. Cutting for State finals

1. It was approved that Kathryn Webb would be the person in charge of finding the cutting judges for state finals.

2. Equipment for the judges was also discussed. We need to find some stands with a divider so

that they don't talk or see each other. Shaun offered some from the UCHA we would just need a flatbed trailer and forklift to move them. Other options were discussed and a decision will be made when it gets closer to state finals to see what may be available.

3. It was discussed that we need to find a herd settler to settle the cutting herd for every go at state finals. A few names came up and were agreed on. Shaun will contact them and see if they would be willing to do it.

4. It was also determined that there would be no need to pre-settle the herd for state finals. The committee was unanimous in the opinion that it didn't save enough time, or it wasn't a great benefit.

5. It was brought to the attention of the committee that we need to put a strong suggestion to

the club secretaries that the cutting and reined cow horse judges need to be paid. We understand that this will be an added expense to the clubs, but the other judges in the rodeo

are getting paid, so why not the cutting/reigned cow horse. It will be proposed in the general

meeting as a strong suggestion and asked if it could go out in the secretary packets.

Page 26-Article X, State Contest

Add a new number #3, remainder to be re-numbered.

If state/provincial association cannot host a State/Provincial Finals due to circumstances beyond anyone's control, including, but not limited to acts of nature, acts of public enemy, animal diseases, riots, flood, or communicable diseases, the NHSRA Executive Committee has the authority to approve an alternate method or plan to create a structure for the states/provinces to qualify to the National High School and/or Junior High School Finals Rodeo.

Students must be under 16 at the first of the National High School Rodeo year (August 1), and are or have been enrolled in the add 5th, 6th, 7th, or 8th grade the year just preceding the National Junior High Finals Rodeo the contestant is entering as long as they (minimum requirements) have made passing grades in at least 70% of the classes taken, even if they have finished the 8th grade in the middle of the year or have attended school on half-days, they will be eligible to compete in the National Junior High Finals Rodeo if he/she has not participated for more than ~~Delete-3, Add-4 years.~~ **(Comment the only way to compete for 4 years is to have enrolled in the 5th grade).**

Page 102, Chute Dogging, III Event Rules, #3, consider editing the rule.

Existing rule: With steers loaded in chute, dogger gets beside the steer, right hand in front of or behind right front shoulder. When dogger calls for the steer the chute gate will be opened. Dogger must keep right hand in front of or behind shoulder until the steer's nose crosses the score line, right arm cannot be under the steer's neck at any time until the steer crosses the score line. If dogger moves into throwing position or touches either horn(s), or ear(s), before steer's nose crosses score line there will be a ten (10) second penalty added to time. If steer is thrown before crossing the score line, the dogger will be disqualified

Consider editing to the following: **With steer loaded in chute, dogger gets beside steer with hand and arm in front of shoulder of steer, or behind shoulder if dogger desires, and can wrap under neck. When dogger calls for steer the chute gate will be opened. Dogger must maintain his arm and hand position without impeding forward progress of steer. Should dogger grab horn, ear, or impede forward progress by choking steer, a 10 second penalty will be assessed. Steer must cross score line before being thrown or starting to slow the steer's forward progress to start throwing process. If steer is thrown before crossing score line, it will result in a disqualification since time has not started. Dogger cannot do anything to start throwing process until time has started in the field. Supporting document available. Page 102, Rule 4 Should be removed as it is addressed in new rule 3.**

Shooting is currently not an approved event and will need to be added to the rulebook as an official event. Current

SECTION IV – TERM OF OFFICE

1. Elections will be held at the General Meeting at the State Finals, with written ballots to be counted by the Vice-president (President-elect), Student President, and Secretary-Treasurer.
2. The term of office of all officers elected at the annual meeting shall commence at the adjournment of the meeting and shall serve until the adjournment of the next annual meeting. Retiring officers will complete all responsibilities connected with National Finals that year.
3. The Executive Board and the Board of Directors will elect all adult directors; they will serve for a two-year term, and may not serve consecutive terms (i.e., Upon completion of a two-year term, a director may not be nominated and/or elected to another term without having set out for a least one year.) If elected to fill a vacancy for a one-year term will be eligible for re-election at the next general election, without setting out one year.
4. The President will nominate 10 Board members who then must be voted upon and approved by the current elected Board members. Term of office for these positions is not limited and they may serve consecutive terms.

1. Elections will be held at the General Meeting at the State Finals, with written ballots to be counted by the Vice-president (President-elect), Student President, and Secretary-Treasurer.
2. The term of office of all officers elected at the annual meeting shall commence at the adjournment of the meeting, and shall serve until the adjournment of the next annual meeting. Retiring officers will complete all responsibilities connected with National Finals that year.
3. The Membership and Board of Directors will elect the Vice President Position; to serve as Vice President, President and Past President. They will serve for a three-year term. Upon completion of the three-year term, the Past President may not be elected to another term as Vice President or an elected Director without having set out for a least one year.) A 2-year director is eligible to run for a vice president position.
4. The Membership and the Board of Directors will elect all adult 2-year and 1-year directors; they will serve for the set term. Upon completion of a two-year term, a director may not be nominated and/or elected to another term without having set out for a least one year. If elected to fill a vacancy for a one-year term will be eligible for re-election at the next general election, without setting out one year.
5. If elected to fill a vacancy for a one-year term will be eligible for re-election at the next general election, without setting out one year.
6. The President will nominate 10 Board members who then must be voted upon and approved by the current elected Board members. Term of office for these

positions is not limited and they may serve consecutive terms.

Shooting Committee

Rule Change presented from the Shooting Committee.

The Shooting Committee would like the Shooting Sports Guideline rules in the UHSRA rule book to be changed as outlined below.

The Rules they ask to be removed from the UHSRA rulebook are all found on page 40 National High School Rodeo Shooting Sports Guide and do not need to be in both rule books.

CURRENT RULES & PROPOSED CHANGES

Shooting Sports Guidelines:

1. It is the responsibility of each shooter to familiarize him or herself with the UHSRA and NHSRA rules. Failure to comply with these rules may result in disqualification.

2. The UHSRA has determined that no electronic listening devices, including iPods, will be allowed by any contestant during his Performance. This is a safety concern and any violation may result in immediate disqualification.

3.21 Electronic Devices-Radios, tape recorders, or any type of sound producing or communications systems are prohibited forward of the ready line except hearing aids and those devices necessary for range control.

3. No coaching will be allowed by other team members or parents once a round of shooting begins. This may result in immediate disqualification.

Contestants are responsible for the safe preparation of all shooting equipment.

This also includes keeping an open chamber indicator in their rifles until it is time to shoot.

Please bring extra shells in the event of a misfire. This is for both rifle and trap. Under no circumstances will a parent be allowed to cross the firing line. Contestants requiring assistance should contact the Range Officer prior to leaving his shooting station. The Range Officer and/or shooting judge will determine the appropriate measures to be taken to assist the shooter.

16.91 Responsibility - It shall be the competitor's responsibility, that:

(a) All equipment meets all rules and match specifications in any match in which that equipment is to be used.

(b) Competitor's position conforms to the rules.

(c) Competitor has full knowledge of the rules under which that match is fired.

10.1.1 Actions Open - Unless the rifle is cased, the action must remain open at all times and the ECI inserted in the chamber. No competitor will aim toward the targets until the proper command is given.

No

rifle will be handled in any manner to violate any rule of safety.

4. Under NO circumstances should a shooter cross the firing line except at the command of the Range Officer.

5. It is each shooter's responsibility to verify that another shooter has not "cross-fired" onto his target. If you suspect a crossfire, you should notify the judge immediately. The judge will determine the validity of your protest and mark the targets accordingly. Contestants who intentionally

or repeatedly crossfire will be disqualified immediately. Cross firing will result in deduction of points according to NRA rules.

13.8 Cross-Fires

(e) If a shooter wishes to disclaim a shot on his target, he must report this immediately to a Range Officer.

9.15 Cross Fire and Excessive Hits - *No competitor will deliberately fire on the wrong target nor fire more than the required number of shots, including hits on some other competitor's target card.*

9.16 Disorderly Conduct - *Disorderly conduct or intoxication is strictly prohibited at the range complex*

and anyone guilty of same will be expelled from the range complex.

6. Banana clips are discouraged and are considered illegal support. If you use a banana clip, you may not rest the clip on the ground or contact the clip with any part of your body during shooting. Resting your clip on the ground or holding the clip while shooting is considered an "unfair advantage" and will result in immediate disqualification.

7. While shooting from the kneeling position, one foot must remain on the ground and the other knee must be in contact with the ground. You may sit on the other foot or leg. Your torso may not touch the ground in any way while shooting.

8. While shooting in all positions, the butt of the rifle must contact one shoulder, and the other hand or arm must be in contact with the fore end of the rifle.

9. While in the prone position, you may use a pad for elbow support. Foot holes or elbow holes may not be dug in the dirt. No part of the elbow pad may be used for additional support or stabilization of the supporting arm.

10. The use of any devices or shooting positions that provide additional support will be considered an "unfair advantage" and will result in immediate disqualification.

5.3 Position of Rifle Butt-*In all positions, except standing (Rule 5.6), the butt of the rifle must be held against the front of the shoulder on the outside of the shirt and must not touch the ground.*

5.4 Prone - *Body extended on the ground, head toward the target. The rifle will be supported by both hands and one shoulder only. No portion of the arms below the elbows shall rest upon the ground or any*

artificial support, nor may any portion of the rifle or body rest against any artificial support. The forearm supporting the rifle shall form an angle with the line from the point of elbow contact, to the target of not less than 30°. (Measured through the axis of the forearm.) 18

5.5 Kneeling - *Buttocks clear of the ground, but may rest on one foot. The rifle will be supported by both*

hands and one shoulder only. The elbow of the arm supporting the rifle rests on the knee or leg. The elbow of the trigger arm will be free from all support. One knee must be touching the ground or shooting

mat. The shooter may be on all, partially on, or all off the shooting mat. A roll as described in Rule 3.12 may be placed under the instep provided the foot is placed toe down at an angle not greater than 45 degrees from the vertical. Only the trousers and underclothing may be worn between the shooter's buttocks and heel. No other article may not be placed between these two points. (Elbow is defined in Rule

5.8.) If the kneeling roll is not used, the foot may be positioned at any angle, to include placing the side of

the foot and the lower leg in contact with the ground.

5.6 Standing - *The shooter shall stand free with both feet on the ground or at his mat without any other*

support. The rifle shall be held with both hands and the shoulder (upper right chest) or the upper arm near

the shoulder, the cheek and the part of the chest next to the right shoulder. However the rifle must not be

supported by the jacket or chest beyond the area of the right shoulder and right chest. The left upper arm

and elbow may be supported on the chest or on the hip. The use of the sling is prohibited for all rifles. (Left handed shooters reverse these descriptions)

5.7 Illegal - *Anyone found using an illegal position shall be warned once and given an opportunity to correct his/her position. If the same person continues to use an illegal position or reverts to it, that person*

shall be penalized according to the provision of Rule 9.20.

11. Once a shooting event has begun, it should proceed without interruption by any contestant except in the event of a weapon malfunction. Intentional interruption or disruption of a shooting event by a contestant will result in the contestant being asked to leave the firing line. He will not be allowed to repeat the event and his score will be judged upon the shots that were fired to that point. This rule will be strictly enforced to allow other competitors to continue shooting without interruption.

12. Trap shooters will be required to carry their shells in a vest or pouch to avoid the unnecessary safety risk of bending down to pick up shells out of a box on the ground. Trap shooters are

required to catch empty shells and collect them in a vest or pouch. Shells will not be allowed to be ejected onto the ground.

13. Trap shooters who wish to contest a lost target must do so immediately after scorer announces "lost".

No protests of trap scores may be made once a contestant has left the range.

The squad leader will determine whether the target was lost or broken. An additional appeal may be made to the judge. The decision of the judge is final.

9.7 Protests or challenges should be voiced immediately after score cards are announced and must be done by the shooter or another shooting contestant. Scorer will verbally call "Lost" or Dead" for each shot fired by each contestant. Disputes and/or protests for an individual shot must be voiced immediately.

14. All trap shooters should verify their scores immediately after the shoot and before leaving the trap range. All protests must be made at this time.

15. No protests of trap scores may be made once a contestant has left the range.

7.10 Every contestant in a squad will be allowed to examine the score sheet before it is turned in. The score sheet should be checked, confirmed and initialed by the Squad Leader (the person who started in

the first position on the left). The Squad Leader is encouraged to verify accuracy of any targets that were

changed and that the scores are correctly noted as dead or lost. After completion, score sheets will be handled as directed by shoot management.

16. All .22 targets will be scored on site within 4 hours of the end of the event. Contestants will be given 1 hour from the time scores are totaled to check targets and protest if necessary. It is the shooter's responsibility to leave contact information to be able to view their targets. After the hour for protesting is up, scores will be turned in to the rodeo secretaries for posting and no protesting will be allowed.

13.1 When to Score - Targets are scored as they are collected from the firing line. Special conditions may require other than this usual procedure.

13.2 Where to Score - Targets may be scored in the office or on the range. Scoring of targets while hanging is prohibited. Whenever targets are scored where backing cards are used, the record target and backing card shall be compared.

15. CHALLENGES AND PROTESTS

The challenge period, unless otherwise resolved during the event, will start immediately after all

targets for the competition have been scored and audited. The challenge period will commence for one (1) hour after all targets have been delivered to the challenge area. Only the competitor will

be allowed in the target review area. Only the contestant will be allowed to review their own target.

ALL scored targets will be available in the designated challenge area AND MAY NOT BE REMOVED FROM THIS AREA until the challenge period is over.

Challenges can ONLY be initiated by the contestant and the contestant is the only individual who

may handle scored targets for initial inspection and for the duration of the challenge period

17. ALL protests for any shooting event must be made by the contestant to the Student Director who will then take it to the Range Master, and/or the Official Judge.

Challenges will be made using this process:

(a) Any challenge MUST go through the Student Event Director first. If not reconciled, then

(b) The Student Event Director and the contestant will consult the Chief Range Safety Officer or Arena Director.

(c) If not satisfied with his decision then, state the complaint orally to the Coordinator. The Student Event

Director, Chief Range Safety Officer, Arena Director and Coordinator will then make a final decision regarding the challenge and notify the contestant.

18. All core Rodeo Events take precedence over the Shooting Events. Because of time and possible facility and volunteer conflicts, shooters must shoot at the time they are assigned. If contestants fail to make their assigned times they will be turned out.

19. Dress Code: The Nationals Finals adopted dress code will be used. Long pants, no open toe shoes, flip flops, etc. Hats are optional. T-shirts or long sleeved shirts required. Members will also be assigned a rodeo back number as part of the dress code. If a contestant is in violation of the dress code they will not be allowed to shoot

10.1 Shooting sports contestants are required to wear contestant/back numbers at all times.

10.2 Jeans/long pants or trousers are required as are shirts and "closed toe" footwear (**Absolutely NO flip-flops, open toed shoes OR SHORTS are allowed.**)

10.3 T-Shirts with crew neck collars and sleeves may be worn. **ABSOLUTELY NO LOW CUT, CUT OFF,**

MIDRIFF OR TANK TOPS OF ANY KIND ARE ALLOWED.

10.4 Any messages on clothing **MUST** be positive and cannot advertise alcohol or tobacco products.

10.5 Western boots and hats are optional. **Spurs are HIGHLY discouraged and contestant may be asked to remove them at any time.**

10.6 Baseball caps are acceptable.

20. Contestants must qualify to shoot at State Finals. Any contestant earning any points in a UHSRA sanctioned shooting event throughout the year can qualify for the State Finals Shoot.

21. A maximum of 70 points can be earned in each shooting event for High School to count towards State Finals (a contestant's top seven shooting scores). A maximum of 60 points can be earned in the shooting event for Jr. High (a contestant's top six shooting scores).

Utah State Finals Point System

The top seven rodeos are counted for State Finals qualifications in the High School Division. The top six rodeos are counted for State Finals qualifications in the Jr. High Division

22. In the Trap event, the ATA tie-breaker rules will be enforced at the State Finals.

Any additional questions, comments, or recommendations should be directed to the shooting Committee Chair

Shot off by presenting 10 targets to each contestant from the 20 yard line for the first tie-breaker.

If a tie still exists, shooters would shoot another 10 targets from the 23rd yard line to try to break

the tie. If a tie still exists, shooters would shoot another 10 targets from the 27 yard line to try to

break the tie. If a tie still exists, shooters will alternate shots from the 27 yard line on post 5 until

the tie is broken.

Backers –

It will be possible for shooters to use backers. It will be voluntary, if a shooter doesn't use them, they must abide by the rule that does not protect them from cross fires and multiple shots in a single hole or area. The plan is to use targets already stapled to a backer to speed things up during target changes.

Rule modifications for Trap –

- Shoot Offs – A shoot off will begin that the 20-yard line. Should a tie breaker for the first shoot off be required the shooters will move back to the 24-yard line and will shoot ten. Should a tie breaker for a second shoot off be required, the shooters will move back to the 27-yard line and will shoot ten, and if still tied will shoot to sudden death. The shooters will shoot in the draw order.

Shot off by presenting 10 targets to each contestant from the 20 yard line for the first tie-breaker.

If a tie still exists, shooters would shoot another 10 targets from the 23rd yard line to try to break

the tie. If a tie still exists, shooters would shoot another 10 targets from the 27 yard line to try to

break the tie. If a tie still exists, shooters will alternate shots from the 27 yard line on post 5 until

the tie is broken.

- Trap Houses – There will be a minimum of 2 trap house's each weekend. Each competitor will get the same "look" at each rodeo unless unforeseen circumstances/technical difficulties prevent this.

- Ranges must meet the minimum standards that provide for 50-yard targets and safety.

6. RANGE STANDARDS

6.4 Distance

(a) Rifle range is 50 yards.

- Turned Out – If a shooter is not there to be registered on time in order to attend the safety briefing, that

shooter will be turned out.

Shooting Position Draw –

- Light Rifle will take precedence and the light rifle draws will remain as they are after being drawn by the

State Secretary.

- In the Trap Shooting, after the draw by the State Secretary, any conflicting contestant

draws between the trap and the rifle will be pulled from the trap shooting draw and then re-drawn by the shooting committee for any open positions throughout the draw before the draw is sent out.

- This drawing system will only be done to accommodate the shooting events.
- The draw will be sent out by the state secretary just the same as all other rodeo events.
- The draw used will be the one for the day the shoot is scheduled and used for both rodeos.

Under no circumstances shall firing commence or continue on a range where an unsafe condition exists.

Under no circumstances shall firing commence or continue on a range where an unsafe condition exists.

New PROPOSED UHSRA Rule

Shooting Sports Guidelines:

Safety, Ammunition, Gun Handling and Guidelines, Regulations, Positions, Range Commands, Challenges, Scoring, Competition, etc. are found online at

National High School Rodeo Shooting Sports Guide.

1. **Rules-** The National High School Rodeo Shooting Sports Guide is the official rule book for the Shooting events. It is the responsibility of each shooter to familiarize themselves with the Shooting Sports Guide and UHSRA rules. Failure to comply with these rules may result in disqualification.

2. **Coaching-** No coaching will be allowed by other team members or parents once a round of shooting

begins. This may result in immediate disqualification.

3. **Firing line-** Under no circumstances will a parent be allowed to enter the shooting stations/area.

Contestants requiring assistance should contact the Range Officer prior to leaving his shooting station. The Range Officer and/or shooting judge will determine the appropriate measures to be taken to assist the shooter. Under NO circumstances should a shooter cross the firing line except at the command of the

Range Officer.

4. **Malfunction-** Once a shooting event has begun, it should proceed without interruption by any contestant except in the event of a weapon malfunction. Intentional interruption or disruption of a shooting

event by a contestant will result in the contestant being asked to leave the firing line. If asked to leave, the

contestant will not be allowed to repeat the event, and his score will be judged upon the shots that were

fired to that point. This rule will be strictly enforced to allow other competitors to continue shooting without

interruption.

5. **Mandatory safety briefing-** All core Rodeo Events take precedence over the Shooting Events.

Because of time and possible facility and volunteer conflicts, shooters must be on time. If a shooter is not

there on time in order to attend the mandatory safety briefing, that shooter will be turned out.

6. **Trap Vest-** shooters will be required to carry their shells in a vest or pouch to avoid the unnecessary safety risk of bending down to pick up shells out of a box on the ground. Trap shooters are required to catch empty shells and collect them in a vest or pouch, shells will not be allowed to be ejected or thrown

to the ground.

7. **Range Requirements-**

-There will be a minimum of 2 trap houses per rodeo weekend

-All Rifle ranges must be approved by the UHSRA shooting committee or chosen from the approved shooting ranges list.

8. **Shooting Position Draw** – The draw will be sent out by the state secretary just the same as all other

rodeo events. After the draw by the State Secretary, any conflicting contestant draws between the trap and the rifle will be pulled and re-drawn. This drawing system will only be done to accommodate the shooting events. The draw used will be the rodeo draw for the day the shoot is scheduled and used for both rodeos.

9. **Student Event Director** - There will be a Rifle Event Director for Junior High and a Rifle Event Director

for High School. The Trap Event Director is also Squad leader. It is the Student Event Director's responsibility to understand and follow all NHSRA Rules and Regulations.

Cutting may be held in conjunction with the rodeo or held at a different time and location for each rodeo. Cutting must be offered the same number of times as all the other events, such as pole bending, bull riding, etc. If OPTION 1 is used, all points earned throughout the year and at the state/provincial finals will be applied toward the All Around.

RCH proposes OPTION 2: RCH event must be offered a minimum three (3) times within each district and/or state/province and their finals. Only the points earned at the finals will count toward the All Around. Points earned at the qualifying events and the state/provincial finals will be used for the year end RCH Champion.

Both committees also will be working on a recommendation for the hosting club on judge's pay at the Cuttings and RCH events. These recommendations will be added to the secretaries' packets. The committee feels this will help clear up some inconsistencies and help the clubs and committee get good judges.
